SENTIMENT FLOW & MICROSTRUCTURE

Short float metrics rest at 9.9%, contrasted against institutional block holdings of 78% which solidifies systemic equity backstops.

Analysis of order book thickness reveals that institutional blocks are quietly building deep support beds, lowering the risk of sudden liquidity shocks before the upcoming

earnings date on Jul 18.
